1. I/We hereby apply for a Private Purchase Permit to import

2. I/We hereby declare that this Application is made on my behalf/on behalf of the partners whose details are particularized in paragraph 13 of this Application.
3. I/We agree that if my/our application is successful, I/We shall be abide by:-
a) The Club's Rules of Racing and Instructions by the Board of Directors
b) The Ownership Bye-Laws of the Macau Jockey Club
c) Instructions by the Racing Committee on Partnerships
d) The Partnership Agreement (if the ownership is in partnership)
4. I/We enclose herewith for the required permit deposit fee HKD _____ by:
a) Bank Cashier's Cheque No./a Cheque No. _____ drawn on _____ (Bank) for HK\$ _____;
b) Cash for HK\$ _____;
c) Visa / MasterCard No. _____ issued by _____ (Bank) to charge for HK\$ _____. (This mentioned sum will incur a service fee of 2.1% , which is charged by Visa / MasterCard respectively.)
5. I/We accept that if my/our application is successful, the permit shall be valid for a period of nine months from the date of issue (or unless otherwise specified), after which it shall become void and the permit deposit fee shall be forfeited without notice.
6. I/We declare that I/We have read and fully understood the Instructions and Specifications as issued by the Club for 2022/2023 Private Purchase Permits.
7. The Applicant undertakes to pay to the Macau Jockey Club all incurred expenses including the cost of shipment, ground transport to the airport in the country of domicile, in Hong Kong and in Macau, a handling fee of HK\$10,000, quarantine charges and veterinary fees, insurance and airport taxes, after the horse has arrived at the appointed holding property, shall be deducted from the Permit deposit. The remaining balance shall be refunded and any deficit shall be charged to the Applicant's Membership account.

All expenses incurred prior to the horse's arrival at the holding property shall be for the direct account of the Applicant or his Agent.

The Applicant undertakes to pay to the Macau Jockey Club all expenses incurred after the horse has arrived at the appointed quarantine property. Notwithstanding the fact that the horse may have been withdrawn from a particular shipment, or if the shipment is cancelled or delayed, the Applicant shall remain entirely responsible for all incurred expenses including those for the reserved airstable space onboard that shipment. In addition, the owner undertakes that the shipping of the horse is at his/her own risk and he/she shall be liable for any additional expenses that may incur.

8. I/We acknowledge that the loss of, the injury to or any illness of a horse before and after importing into Macau shall not be the responsibility of the Macau Jockey Club and shall be my/our responsibility.
9. I/We acknowledge that the horse(s) will be insured for transit (mortality cover only) upon request. The cost will be 0.6% of the horse's value, subject to revision if necessary, and that covers mortality insurance only up to 30 days in the quarantine station prior to transit, the journey to Macau and 30



days after arrival in Macau. I/We understand that the acceptance and effectiveness of such “Insurance For Transit” will be subject to the declaration made by me / us to the Club of a valid Permit No. and a veterinary report on the horse passed by the Club’s Veterinary Surgeon and confirmation from the Quarantine Veterinary Surgeon certifying that the horse has arrived at the quarantine station free of any injury, illness or disease. Note that the insurers reserve the right to place an exclusion for any pre-existing conditions. Transit insurance cover over the 30 days shall be subject to an additional 3.6% pro-rata. (“Loss of Freight” insurance cover is mandatory and claimable in the event the horse is withdrawn from the shipment due to illness/injury prior to the flight and must be certified by the vet unfit to travel and subsequently approved by the insurance company. This shall apply per horse/per shipment for a maximum freight liability of HK\$40,000. (The standard premium rate is 2.32% for a period or not more than 30 days, additional premium shall apply for additional days on cover and is subject to revision if necessary.)

10. I/We acknowledge that the Macau Jockey Club has the authority to charge to my/our account any deficit for any additional charges incurred, including the handling fee of HK\$10,000. A monthly administration fee of HK\$600 will be charged for 12 months after the horse arrival as a contribution towards the horse retirement fund.
11. Should this application not be successful, refund shall be made by cheque to the Applicant.
12. I/We hereby declare that the statements contained in this application are true and accurate in all respects. Should it be established to the satisfaction of the Board of Directors that this application has been made for and on behalf of a third party or should the statements contain any false or incomplete issue, I and my other parties involved will accept disciplinary proceedings pursuant to the Rules and Regulations of the Macau Jockey Club.
13. I/We accept that if a newly licensed trainer is being nominated, the horse so assigned shall not be transferred for a complete Season. If my/our application is successful, I would like this horse to be trained by _____ Stable.
